2022 ACHIEVEMENTS

A Historic case in the US Supreme Court Against the Social Media Over Incitement to Terrorism

In response to the Palestinian 2015 knife Intifada, Shurat HaDin launched a legal campaign against the social media platforms that aided and abetted the terrorists. Palestinian terror groups called for murders, raised money, and glorified their violence on Facebook, Twitter, and YouTube. Innocent Israelis were killed as a result of this online incitement. Social media companies have continuously claimed that Section 230 of the 1996 Communications Decency Act absolves them from being considered the publishers of what is featured on their sites since the material is posted by third-party users.

This fall, though, the U.S. Supreme Court granted cert in *Gonzalez v. Google*, our landmark legal action against the California-based social media giants. The case has the potential to finally change the archaic internet laws that have allowed incitement, violence, and hate to be promoted online.

A Judgment Against Hamas for NIS 38 Million on Behalf of the Families of Three Teens Kidnapped and Murdered in 2014



On June 12, 2014, three Israeli teenagers—Eyal Yifrach, Gilad Shaer, and Naftali Fraenkel—were kidnapped and murdered by Hamas terrorists. Their bodies were found eighteen days later.

Hamas then launched hundreds of rockets into southern Israel. The Israel Defense Forces responded with “Operation Protective Edge,” and entered Gaza to eradicate the terrorist rocket and tunnel infrastructure.

Shurat HaDin, representing the families of the murdered boys, sued Hamas for NIS 500 million. A Jerusalem District Court only awarded NIS 38 million (\$11.8 million), but in an unprecedented decision, the court demanded that the Palestinian Authority pay the damages. The Palestinian Authority sends millions of dollars a month to Hamas so that the terrorists can administer Gaza. If the court’s decision is ignored, we will demand that the funds be taken from the tax money that Israel transfers to the Palestinian Authority.

We will appeal the amount awarded to the families.

Winning a \$111 Million Judgment Against Hezbollah

In September, a federal judge in the Eastern District of New York ruled that Hezbollah, the Iranian-back Lebanese Shiite “Party of God” violated the U.S. Anti-Terrorism Act when the rockets it fired during the 2006 Second Lebanon War wounded American citizens in Israel. Hezbollah was ordered to pay \$111 million in damages.

The conflict began when Hezbollah launched a cross-border raid and seized two mortally wounded Israeli soldiers. During the thirty-three days of combat that followed, Hezbollah violated international law when it fired thousands of missiles into the towns and cities of northern Israel. Hezbollah’s missile arsenal has quadrupled since 2006; their warheads are larger and more accurate.

Shurat HaDin founder and president Nitsana Darshan-Leitner elaborated on the ruling’s important message, “Only by exacting a heavy price from those who engage in the business of terrorism can we prevent the suffering and loss of additional victims to their violence.”

Lawsuit Against the Qatari Banks and Charities for Funding Hamas



The State of Qatar supports numerous Islamic fundamentalist terror groups, including the Muslim Brotherhood and ISIS; the tiny oil-rich nation is the primary benefactor of Hamas, providing the group with billions of dollars in aid funneled through banks and Islamic charities. The Qatari money is ostensibly intended to benefit the Palestinians in the Gaza Strip, but instead finances terror tunnels, terrorist salaries, and missiles aimed at Israel.

In June 2021, Shurat HaDin filed a historic NIS 1 billion lawsuit on behalf of 120 individual plaintiffs—including the family of Daniel Turgeman, a four-and-a-half-year-old from Kibbutz Nahal Oz killed by Hamas rockets in 2014—against Qatar and several Qatari banks for providing the logistical support for Hamas attacks that killed and wounded Israelis.

Shurat HaDin founder and president Nitsana Darshan-Leitner proclaimed, “If Israel cannot prevent Qatari funding of Palestinian terrorism, then the victims of terrorism will act to prevent it.”



War Crime Complaint with the ICC Against Hamas Over Firing Rockets Into Israel

Israel's enemies have used the International Criminal Court in The Hague as a headline-grabbing weapon to vilify the Jewish state. Shurat HaDin has decided to test the legitimacy and impartiality of this court by filing a complaint charging Hamas perpetrated war crimes for targeting Israel's population centers with indiscriminate rocket fire.

In May 2021, Hamas fired 4,360 rockets and missiles against the towns and cities of southern Israel during eleven-days of terror. Targeting civilians in a conflict—as per the ICC's own Rome Statutes—is a war crime. Hamas is also guilty of using its population as human shields, and specifically trying to kill Jews—holding hostages and targeting a specific religious group are war crimes, as well.

Shurat HaDin demands that Hamas military commander Mohammed Deif and political chief Ismail Haniyeh be brought before the tribunal to answer for these heinous violations of international law.

War Crime Complaint with the ICC Against Palestinian Authority President Over the Pay to Slay Policy



On the night of June 30, 2016, a Palestinian terrorist infiltrated the settlement of Kiryat Arba and snuck into the home of Hallel Ariel, a fourteen-year-old girl, and promising dancer, and fatally stabbed the teenager as she slept. The terrorist—who was later shot and killed—had forewarned his intentions of becoming a martyr in posts on Facebook.

The PA pays terrorists and their families generous stipends after committing acts of terror against Jews, and Shurat HaDin filed a lawsuit against the Palestinian Authority on behalf of Hallel's parents for rewarding their daughter's murderer. We also filed a war crimes complaint against PA President Mahmoud Abbas about the "pay for slay" incentives. In a sharply worded letter to the ICC, we stressed that although the Palestinian Authority is not a sovereign state, Abbas is a citizen of Jordan, which is an ICC member state, and subject to the court's jurisdiction.



Lawsuit Against Iran Over Torture of South Lebanese Army Veteran

Amer Fakhoury fought in the predominantly Christian South Lebanon Army alongside Israeli forces in southern Lebanon. The Fakhoury family resettled in Israel in 2000 after the IDF withdrawal and eventually immigrated to America. In 2019, Fakhoury, now a naturalized U.S. citizen, traveled to Lebanon after ensuring that his safety was guaranteed.

But Fakhoury was arrested in Beirut by Hezbollah-controlled Lebanese intelligence. He was tortured, denied medical care, and fell ill; a malignancy was not diagnosed. Amer Fakhoury was released months later after U.S. pressure on the Lebanese government. He died in August 2020. He was 57.

Shurat HaDin sued the Islamic Republic of Iran in U.S. federal court on behalf of the Fakhoury family. Hezbollah, a U.S. designated Foreign Terrorist Organization and Iranian proxy, ordered Fakhoury's imprisonment and torture; they are responsible for his murder. In similar lawsuits, U.S. courts have ordered Iran to pay billions of dollars in damages.



Fighting the United Nations Human Rights Council's Institutionalized Antisemitic Agenda in Geneva





The Geneva-based U.N. Human Rights Council (UNHRC) dispenses injustice and hatred with an antisemitic and anti-Israeli agenda. It established the Pillay Commission with the sole mission of vilifying Israel. When the Pillay Commission declared that Israel's "occupation" of Palestinian territory violates international law and demanded that Israeli soldiers be prosecuted in the International Court of Justice for war crimes, Shurat HaDin flew a group of IDF reservists to stage a large protest outside the body's European headquarters.

In 2021, the Biden administration rejoined the Pillay Commission after a four-year absence, arguing that it would be easier to defend Israel from within, and promising to obstruct the anti-Israel activities. But its heinous anti-Israel agenda continues unabated. Shurat HaDin relentlessly lobbies governments from across the world to remove themselves from the UNHRC, and we demand that the U.S. government declare the Pillay Commission a hate group, and immediately resign from its ranks.

Fighting Ben & Jerry's Over Boycotting Israel and Exposing Their Woke Hypocrisy

An initiative organized by Shurat HaDin is striking back at the Ben and Jerry's ice cream manufacturers for their anti-Israel bias and sheer hypocrisy.

Over 1,000 Israeli university students signed a letter to Anuradha Mittal, the Ben and Jerry's Chairperson, demanding that the company evacuate its factories and headquarters in Vermont from "illegally occupied" Abenaki Indian lands. The Ben and Jerry's corporation sits on three New England properties that once belonged to North American indigenous tribes, and the students want to hold the company's leadership accountable to the same argument compelling Ben and Jerry's to boycott Israel.

In the letter, the students wrote "We know you are calling for Jews to vacate Judea and Samaria, therefore we call upon you to evacuate your factories in Vermont because this is occupied territory. This is not a war against ice cream. It's about the hypocrisy of the BDS movement."

Demanding Extradition for the Terrorist Responsible for the 2001 Sbarro Pizzeria Suicide Bombing

On August 9, 2001, 15 people, including 7 members of the same family, were killed in the Hamas suicide bombing of the Sbarro pizzeria in downtown Jerusalem. Scores were wounded.

Ahlan Tamimi, a 21-year-old Jordanian-born Palestinian led the bomber to the restaurant. She was arrested after the attack, convicted of mass murder, and sentenced to 16 life terms. Tamimi was freed in the lopsided 2011 Gilad Shalit prisoner exchange and deported to her native Jordan.

Because 2 Americans were killed in the bombing, Tamimi was placed on the FBI's Most Wanted Terrorist List. The Trump administration demanded her extradition, but because Jordan is a key strategic American ally, she remains free. She is now an Arabic media star boasting of her role in killing Israelis and Jews.

Shurat HaDin will not relent in its pressure on the U.S. government demanding that Tamimi be extradited and prosecuted for her heinous crimes.



Going After Terrorists' "Pay to Slay" Salaries to Execute a Judgment Awarding Compensation to the Terror Victims

On May 2, 2021, Muntasir Shalabi, a Palestinian terrorist, shot and killed 19-year-old Yehuda Guetta, and critically wounded two of his classmates, Benaya Yisrael Peretz and Amichai Halah, as they waited for a ride at Tapuah Junction. An IDF Military Court convicted the 44-year-old Shalabi; he was sentenced to 2 life terms. The court awarded the Guetta family NIS 1.5 million in damages for their anguish and suffering; the Peretz family received NIS 1 million. Shurat HaDin represents both families.

In proceeding to enforce the Jerusalem court's judgment, we have targeted the "pay to slay" stipend that Shalabi is receiving from the Palestinian Authority for murdering Israelis. By ensuring that monies are directed toward the victim and not the killer. This is the only way to hurt the Palestinian leadership for their policy of rewarding the terrorists and serving justice for their victims.





Joining Forces With the State of Texas to Combat BDS

Shurat HaDin, together with Texas attorney, Jay M. Goldstein, has filed an Amicus Brief in the Court of Appeals for the Fifth Circuit, Texas, in the case of A&R Engineering and Testing, Inc. v. Ken Paxton, Attorney General of Texas.

A&R Engineering, a Palestinian-owned firm in Houston, sued to repeal the Texas law prohibiting the awarding of state contracts to companies that participated in the Boycott, Divestment, and Sanctions movement (BDS) against Israel, claiming it violated its First Amendment right of free speech to participate in economic boycotts as a form of protest.

Initially, the district court found for A&R Engineering. The Texas Attorney General appealed. Shurat HaDin's Amicus Brief exposed BDS as a discriminatory movement designed to delegitimize and eradicate Israel. The targeting of Jews and Israelis—especially with taxpayer-funded state contracts--solely because of their religion or national origin cannot be protected under First Amendment jurisprudence.

Nitsana Darshan-Leitner Named as One of the 50 Most Influential Jews of 2022

Shurat HaDin founder and president Nitsana Darshan-Leitner was honored by the Jerusalem Post and named one of the 50 most influential Jews of 2022. Since it was founded in 2002, Shurat HaDin has sued terror groups, their state sponsors, and the banks that facilitate their blood money, in courtrooms around the world. The Israeli-based human rights NGO has won mega-judgments against Iran, Syria, North Korea, and the Palestinian Liberation Organization, on behalf of the victims of terror.

“We are fighting an enemy that does not refrain from using any weapon to undermine the right of the Jewish people to reside on its land and live in peace in an independent homeland,” Darshan-Leitner explained. “Therefore, we also have to think out of the box,” she added. “When you go into a [legal] war against a movement, you cannot go with your hands tied behind your back. You need to be creative.”

The Attorneys: Taking Terrorism to Court

Adv. Nitsana Darshan-Leitner — founder and president of the Israel Law Center, which wages court battles against terrorist organizations —is working alongside the Mossad to bring terror operatives to trial and win full compensation for terror victims. Daniel Dotan, BrandVoice | 20 November 2022



Adv. Nitsana Darshan-Leitner has probably spent more time with terrorists than any other Israeli attorney. The Israel Law Center, a legal organization she founded two decades ago to oppose terrorism, has ensured more verdicts against terrorist criminals than any other organization in the world, and her campaign isn't even close to an end.

She represents victims of terror, suing terrorist organizations and whoever supports them: states, banks, and large corporations that assist terrorism. She fights against the delegitimation of the State of Israel around the world, and she battles on behalf of Israeli soldiers at the criminal court in The Hague. She has succeeded in winning verdicts totalling billions of dollars and has obtained hundreds of millions for the benefit of the victims. She has wrought change in the international banking system, in that no bank now dares to open a bank account for a terrorist organization or to operate in regions dominated by terrorism. In addition, she has stopped Gaza-bound flotillas and thus prevented confrontations with Israeli soldiers.

Adv. Nitsana Darshan-Leitner started on her career of opposing terrorism as long ago as the early 1990s, when she was studying law. "Muhammad Abu Abbas was coming to Israel for the signing of the Oslo Accords between Israel and the PLO. He was a leader of the PLO and one of the planners of the hijacking of the Achille Lauro some years earlier, in which Leon Klinghoffer, a Jewish American, was murdered in cold blood," says Adv. Darshan-Leitner. "A group of us law students turned to the Supreme Court in opposition to the decision to admit him into Israel, and I was the one they designated to deliver the plea to the court. Although three justices of the court recommended withdrawing the plea, I persisted out of a sense of mission and a desire for justice, because the blood of Leon Klinghoffer was crying from the ground. "In the end, the justices ruled that they saw no justification for intervening, but they didn't charge us with court costs. I understood, from that moment on, that my goal in life was to make the voice of the victims of terror heard," she says.

Throughout her studies, Adv. Nitsana Darshan-Leitner continued working on behalf of the victims of terror and for human rights, and in time she opened an office for civil law in Modi'in. In 1993 she married Ariel Leitner, an American by birth, who earned a Master's degree in law at Bar-Ilan University. After giving birth to a son and daughter, she had triplets (a boy and two girls) and subsequently gathered her strength to bear one more daughter. With success and with great determination, she combines her family life and her impressive professional career.

Adv. Darshan-Leitner was awarded the 2012 Moskowitz Prize for Zionism. In 2014, a leading newspaper named her as one of the world's 50 most influential Jews, and in 2015 she was chosen by a women's magazine as one of the 50 most inspiring women in Israel. Following her legal successes against boycotters of Israel, such as Airbnb and Ben & Jerry's, and the verdicts she won against the Palestinian Authority, Hamas, and Iran for hundreds of millions of shekels, this year she was again named one of the world's 50 most influential Jews. In her intriguing book Harpoon, written together with author Samuel M. Katz, Adv. Darshan-Leitner tells the story of the Mossad's Harpoon unit. The book was published first in the USA (by Hachette Books) and more recently in Israel (by Yedioth Books). It reveals the story of a secret unit set up by Meir Dagan in order to dam the channels through which money to finance terrorism flowed.

The guiding principle, according to her, was "'In a place where there is no humanity, strive to embody humanity.' At the Israel Law Center, we wage the State of Israel's legal battle. As a private attorney, I am not restricted the way the State is, and I am free to do all this for the sake of the State and for the sake of justice. I find that this strengthens my commitment to public service day by day. My goal is to make the enemies of Israel pay for the spilling of Jewish blood. To show the world that no one will murder Jews any longer without bearing the consequences."

Adv. Darshan-Leitner is currently beginning a second phase of her life's work: She is running for the Knesset as a member of the Jewish Home Party in order — in her words — "to lead the fight for the sake of the State, with the same determination, from the Knesset floor."
